
Inspection of Aged Home by the Manipur State Commission for Women




From 16th September,2021 till 8th September,2022, Manipur State Commission for Women received 85 nos of complaint case. 68 nos of complaint cases were successfully closed and 17 nos are still running. Domestic violence related case again top the chart of the complaint cases in the Commission.

The Commission received cases like harassment, marital dispute, fraud, harassment at work place, domestic violence, dowry, bigamy physical assault, maintenance, desertion, police apathy, breech of agreement, attempt to murder, molestation, etc.

Since inception, the State Women Commission received 1,115 nos of complaint cases. During the 2021-22, the Commission received the highest number of complaint from Imphal West District and is followed by Imphal East, Thoubal,Bishnupur,Kakcing, Churachandpur, Kangpokpi, and Chandel.




Complainant's age as recorded in the Commission







Know Your Rights

- > The Police Officers arresting and interrogating a woman must wear clean and visible identification and nametags with their designation.
- > Police cannot handcuff a woman without permission from a Judge.
- A Woman must be told the reason for arrest of a woman, and informed of a woman's rights to bail and rights to a lawyer.
- > Relatives/friend must be informed of an arrest of a woman and place of custody.
- Police must prepare a memo of arrest, signed by women's family member, a respectable person from the area where the arrest is made.
- Police must make an entry in the diary of the place of custody regarding the arrest, the relative/friend who was informed and the officer in whose custody the woman are.
- the arresting officer must inform the police control room about the arrest and place of custody which should be displayed on a conspicuous notice board.
- A woman police constable must be present at the time of arresting a woman.
- > A woman can be physically searched by another woman only.
- A woman arrestee must be detained in a woman's Lock-up.
- > No woman should be arrested after sunset and before sunshine.



UN AND WOMEN'S RIGHT

Women represent half of the world's population and any violation against women will amount to violations of the rights of the half of the population which is ostensibly an act towards a regressive world. However quite sadly the UN Secretary-General, Mr. António Guterres has stated that "achieving gender equality and empowering women and girls is the unfinished business of our time, and the greatest human rights challenge in our world." But it needs no reiteration that this challenge needs to be met and overcome. The war for gender equality and against violence against women has been waged by UN since 1948 itself when Gender Equality was made part of international human rights law through the Universal Declaration of Human Rights, which was adopted by the UN General Assembly on 10 December 1948. That milestone document in the history of human rights recognized that "All human beings are born free and equal in dignity and rights" and that "everyone is entitled to all the rights and freedoms set forth in this Declaration, without distinction of any kind, such as race, colour, sex, language, religion, ... birth or other status."

the General Thereafter, Assembly declared 1975 as the International Women's Year and organized the first World Conference on Women, in Mexico City which led to the declaration of the years 1976-1985 as the UN Decade for Women, and establishment of a Voluntary Fund for Decade. The second world conference on women was held in 1980 in Copenhagen, which marked the middle of the United Nations Decade for Women. It adopted a resolution on "battered women and violence in the family" and referred to violence in the home in its final report. In 1985, the World Conference to Review and Appraise the Achievements of the United Nations Decade for Women: Equality,

Development and Peace, was held in Nairobi. Realizing that the goals of the Mexico City Conference had not been adequately met, the 157 participating governments adopted the Nairobi Forward-looking Strategies to the Year 2000. The document broke new ground by declaring all issues to be women's issues.

These three conferences not only urged to generally protect women's right but also identified a number of areas of special concern, including "abused women", "women victims of trafficking and involuntary prostitution" and "women in detention and subject to penal law" and governments were urged to establish or strengthen forms of assistance to victims of violence through the provision of shelter, support, legal and other services and to increase public awareness of violence against women as a societal problem.

Another landmark in the history of UN for women is that, in 1979, while UN Decade for Women, was being observed, the General Assembly adopted the Convention on the Elimination of All Forms of Discrimination against Women (CEDAW), which is often described as an International Bill of Rights for Women. It is not only the most comprehensive but also the principal international document to address the right of women to be free from discrimination.

After Nairobi, the Fourth World Conference on Women, held in Beijing in 1995, went a step further than the Nairobi Conference. The Beijing Declaration and Platform for Action asserted women's rights as human rights and committed to specific actions to ensure respect for those rights. On 2 July 2010, the United Nations General Assembly unanimously voted to create a single UN body tasked with accelerating



progress in achieving gender equality and women's empowerment. The new UN Entity for Gender Equality and the Empowerment of 2 Women – orUN Women– merged four of the world body's agencies and offices: the UN Development Fund for Women (UNIFEM), the Division for the Advancement of Women (DAW), the Office of the Special Adviser on Gender Issues, and the UN International Research and Training Institute for the Advancement of Women. The main roles of UN Women are:

- To support inter-governmental bodies, such as the Commission on the Status of Women, in their formulation of policies, global standards and norms.
- To help Member States to implement these standards, standing ready to provide suitable technical and financial support to those countries that request it, and to forge effective partnerships with civil society.
- To hold the UN system accountable for its own commitments on gender equality, including regular monitoring of system-wide progress.

Grounded in the vision of equality enshrined in the UN Charter, UN Women, among other issues, works for the:

- elimination of discrimination against women and girls;
- empowerment of women; and
- achievement of equality between women and • men as partners and beneficiaries of development, human rights, humanitarian action and peace and security. Another historical act is the inclusion of gender equality and empowerment of women as one of the 17 SDGs. It has been recognised that Women have a critical role to play in all the 17 SDGs, with many targets specifically recognizing women's equality and empowerment as both the objective, and as part of the solution. And of these17 SDGs, Goal 5 specifically aims to "Achieve gender

equality and empower all women and girls" which is known as the stand-alone gender goal. However while a record 143 countries guaranteed equality between men and women in their Constitutions by 2014, another 52 had not taken this step.

Before parting it will be profitable to mention that the Commission on the Status of Women (CSW) is the principal global intergovernmental body exclusively dedicated to the promotion of gender equality and the empowerment of women. The CSW is instrumental in promoting women's rights, documenting the reality of women's lives throughout the world, and shaping global standards on gender equality and the empowerment of women. Another profound action in bringing awareness among the people of the world is the observance of International Women's Day annually on 8 March. International Women's Day first emerged from the activities of labour movements at the turn of the twentieth century in North America and across Europe. It is a day, observed by many countries around the world, on which women are recognized for their achievements without regard to divisions, whether national, ethnic, linguistic, cultural, economic or political. Also the International Day for the Elimination of Violence against Women is observed on 25 November. Besides these observances, the UN observes other international days dedicated to raising awareness of different aspects of the struggle for gender equality and women empowerment. On February 6, the International Day of Zero Tolerance to Female Genital Mutilation is observed, February 11 is the International Day of Women and Girls in Science, June 19 is the International Day for the Elimination of Sexual Violence in Conflict, June 23 is International Widows' Day, October 11 is the International Day of the Girl Child and on October 15 the International Day of Rural Women is observed.
